
Working with the Information Centre, Kate has been helping to update and analyse the center's website in preparation for the return of significant cruise ships and tourists to the town from late next year.

WHAT CAN YOU OFFER CRUISE SHIP PASSENGERS?

Do you have an idea or two of a tour, trip or experience you could offer to cruise ship passengers when all the ships return to 'Lyttelton, Port of Christchurch' this time next year?

Perhaps you are already offering something that could be adapted for cruise ship passengers or the crew?

Whether it is for 2 or 52 passengers, walking, biking, car, van or bus trips, or perhaps a day class, the Information Centre wants to know about it NOW so that it can be part of the listing that we are putting together to offer to the Cruise passengers via their Destination Managers.

The sooner we know what you can offer the sooner we can prepare our list and ideally have it ready to offer to the passengers from the smaller ships that are coming into port this summer.

On 6 August, the Lyttelton Harbour Information Centre Board, supported by the Banks Peninsula Community Board held an informal drop in session at the Rec Centre in Lyttelton. The purpose of this get together was for anyone interested being able to put forward their point of view about the return of cruise ships in October 2020. It was also an opportunity for existing and potential tour providers to have a talk with members of the Board and some Council staff.

Topics discussed were how passengers will leave the wharf, where buses will park, where tour operators will park, how Lyttelton can look its best and provide a memorable experience for those passengers wanting to stay in Lyttelton or around the harbour for the day—maybe visiting Governor's Bay, Orton Bradley Park and Diamond Harbour. Possibly a ferry ride. Some passengers may like a visit to the Timeball Station and over the hill to Sumner. Bike riding would also be popular as well as walking on the Port Hills, or a history

walk around Lyttelton. Would you like to host golf days for passengers, or a pottery, art, cookery or photography class for the day? Whatever your idea is why not talk to us. There will be flexibility about how many Cruise Ship Days you offer your experience.

Tour operators were able to find out more about plans being developed around the return of cruise ships to Lyttelton, and although we do not know all the answers yet, we will be happy to pass on the answers as soon as things are finalised.

Members of the Lyttelton Harbour Information Centre Board have been hard at work for several months, planning to make sure the experience offered to passengers will be the best possible, and we need to know what you are planning, as we are starting to put together some promotional information, which we hope will be added to the film played to the passengers in their cabins a couple of days before they arrive in port, and we need to know what is going to be on offer.

We are also planning a leaflet for all those passengers who are not leaving the ships on pre-booked coaches and are making their first stop the town of Lyttelton, while they decide what they might do on their day here.

UPDATE LPC — OIL BERTH

We are undertaking repair and strengthening work on our oil berth, extending the longevity of this vital resource for Canterbury.

The LPC oil berth was badly damaged during the Christchurch earthquakes, and work to strengthen the berth is underway and will be completed by mid-2020.

Some of the construction activities require the berth to be closed from October 14 to 22. To ensure the berth is reopened as soon as possible for customers fuelling the South Island, we need to work for longer hours during the week the berth is closed.

When are we doing it?

Fulton Hogan is the contractor working onsite, and during this time, construction work will occur typically between 5 am and 11 pm, but some 24 hours works may be needed. We are working with the Contractor to ensure, where possible, they programme the noisier activities during normal daytime working hours.

ELECTRIC FERRY PLAN FOR DIAMOND HARBOUR ROUTE

Trips across Lyttelton Harbour could become a lot more environmentally friendly if a battery electric ferry comes on board. Black Cat Cruises, which has been operating the Diamond Harbour Ferry service since 2000, is investigating buying a battery electric vessel to replace their current Black Diamond ferry, which is 18 years old. Christchurch City Council and Crown agency EECA – the Energy Efficiency and Conservation Authority - have agreed to provide funding towards the project.

Black Cat Cruises Chief Executive Paul Milligan says the service is growing in popularity and a larger vessel is needed. The company is always looking for ways to minimise their impact on the environment and it's excited about investigating the possibility of an electric ferry.

"The relative short trip times of the Diamond Harbour Ferry Service and the access to charging at the Lyttelton Port end make it the ideal ferry to further develop and test marine battery electric technology. We look forward to bringing the next generation in passenger ferry travel to Lyttelton Harbour in 2021.

"A fully electric, zero exhaust emission vessel would not only be good for the environment through the reduction in greenhouse gas emissions, but also reduced engine noise for the marine mammals in the harbour."

Early investigations suggest that using two 250 kW electric motors would reduce greenhouse emissions from the ferry by about 344 tonnes per year. A detailed feasibility study is planned for completion by early next year and if everything goes to plan, a full battery electric ferry could be sailing between Lyttelton and Diamond Harbour early in 2021.

The Council will provide a \$45,000 grant towards the purchase of Black Cat's battery electric ferry through the Innovation and Sustainable Development Committee. EECA will be providing \$200,000 towards the project. Kevin Crutchley, the Council's Resource Efficiency Manager, says the project aligns well with the Council's goals of reducing greenhouse gas emissions and air pollution from Christchurch's transport.

"Transportation represents around 53 per cent of Christchurch's greenhouse gas emissions and this innovative project is another example of how Christchurch organisations are working together on practical ways to reduce these emissions," Mr Crutchley says.

Other examples include the battery electric bus service that Red Bus launched in July this year, the battery electric car sharing service Yoogo Share, the roll-out of charging infrastructure for electric vehicles across the city, and the launch of Take Charge Christchurch.

He says battery electric vessels are a new, innovative technology in New Zealand. "Having a zero exhaust emission ferry operating on Lyttelton Harbour will demonstrate this exciting new technology to both the public and to the marine industry."

Christchurch won the 2019 Most EV Friendly Town of the Year Award, the second time it has won this award.

PLENTY OF WORK STILL TO DO TO ADDRESS ENVIRONMENTAL AND CLIMATE ISSUES

The job of being a regional councillor is both rewarding and frustrating. When I confess to friends that I have enjoyed the past three years in this role, initially as an elected councillor and then as chair, they express amazement or they say "God, I don't know how you stand it!"

One thing is abundantly clear, you can't please everybody any of the time. There are so many competing interests around what we do that dissent is inevitable.

Our work is varied and complex. As well as the huge job of freshwater management we oversee bus services in Greater Christchurch and Timaru; we manage air quality and the coastal marine environment; our river engineers provide flood protection, and we are focused on biological diversity and security.

We have been a transitional council, moving from the era of Government appointed commissioners to the return of a fully democratically elected council.

New council taking the reins

Following the election on 12 October the Environment Canterbury Act will expire and a new council will take the reins.

In early 2017 we restated our strategic purpose – to facilitate sustainable development for the Canterbury region.

- We all want to breathe clean air, play and swim in the rivers, gather mahinga kai, benefit from the productive use of our land, and enjoy our biodiversity taonga and landscapes
- We want to live, travel, and move goods with ease, facilitating work, leisure and tourism
- We want to have access to the information we need to be resilient in the face of short-term hazards and well-prepared for longer-term change to our region's natural environment

We can all help shape the future of Canterbury, leaving a legacy for generations to come.

Building strong relationships

The regional council cannot do this work alone and to help us we have forged strong relationships with organisations and communities across Canterbury.

This starts with our special partnership with Ngāi Tahu and we meet regularly with the 10 papatipu rūnanga which keeps us grounded in our Tuia relationship with the Iwi.

We work closely with the 10 territorial authorities across Canterbury which includes regular visits to build understand and trust. We also manage the administration of the Canterbury mayoral forum, who have driven the Canterbury Water Management Strategy which is the New

Zealand benchmark for community-led decision making.

As an arm of local government, however, we operate under acts of parliament and can end up as the meat in the sandwich between central government regulations and the communities that are affected by them.

Action for healthy waterways

The Government's recent "healthy waterways" proposals are a good example of this. While environmental groups have largely welcomed the proposals, the farming sector is concerned about farm viability if the proposals go through in their current form.

Some aspects of the proposals seem to be an attempt to see how far things could go – for instance, the 1 mg/l level for nitrate in rivers. While the science may support that very low level, we must also consider cultural, social and economic matters when setting water quality limits, and it's likely the limit in the final version of the NPS will change.

Achievements in Canterbury

In Canterbury, it has been known for a long time that land-use intensification was causing rising nitrate levels in groundwater (at least since a 1977 report) but practices continued unabated for 30 years and more until matters came to a head.

Over the past nine years, our most significant achievement has been the introduction of a set of Resource Management Act regional plans over the whole of Canterbury as the first step in dealing with nitrate and other land-use issues.

These plans are like a korowai or cloak that provides a measure of protection for the quantity and quality of our freshwater.

The pace has been rapid and the scale of change massive: councillors have exercised judgement in terms of how fast we can push our communities.

We are seeing very good progress with plan implementation – all 1500 farms managed by collectives have Farm Environment Plans in place and 66% of the remaining 1400 individual farms either have or have lodged a land-use consent to farm and prepared a Farm Environment Plan.

Last year 90% of Farm Environment Plans received a compliant A or B grade when independently audited. In the compliance space, we have continued to focus on high-environmental risk consents, again with good results, with 84% of monitored water consents receiving an A compliance grade last year. We lead New Zealand in this sphere.

Changes ahead in planning process

The government's freshwater proposals, however, are likely to kick off a new round of plan changes.

In large part, the planning work over the past few years has been led by the tireless work of water management zone committees – which despite some poorly informed criticism, have been highly effective in getting community input into council plans and work programmes.

Yes, many of the zone committees have farmer members, but they also have rūnanga, community and council representatives and most decisions are consensual.

The committees are only able to make non-binding recommendations to the council. Our plans are subject to submissions then reviewed by an independent panel of hearing commissioners – who work to a very high standard of evidence and law – to ensure they meet the stringent requirements of the RMA.

On the ground actions

In the meantime, our attention continues with the on-theground actions.

Zone committees and Environment Canterbury staff are focusing more and more on fencing, planting riparian strips, restoring wetlands and ecosystems, as well as replanting steep land and conserving soil.

Environment Canterbury has close to 300 projects on the go at any given time aimed at repairing, restoring or improving environmental and ecosystem values across the region. The cumulative effect of all this activity is hugely positive.

All this practical work aligns closely with our focus on biodiversity and biosecurity signalled in our Long-Term Plan 2018-28. This has included a biodiversity strategy, as well as new work programmes in braided rivers and wetlands. Since 2016, more than two million hectares, or 43%, of Canterbury has been searched and treated for wilding pines (multi-agency cost: \$8.8 million).

Transport and urban development

Having said that by far the biggest portfolio, measured by expenditure, is transport and urban development.

In collaboration with the City, Selwyn and Waimakariri we have produced a Regional Public Transport Plan which includes a transition to electric vehicles, rapid transport corridors and an on-demand public transport system for Timaru.

We have navigated our way through proposed bus route changes in the Long-Term Plan to reach a solution that helps deal with the financial pressures while still providing for the needs of people who would have been most affected by our initial proposed changes.

Over the past couple of years, we have seen the first growth in Christchurch public transport patronage since the 2010/11 earthquakes.

Many of the Christchurch earthquake regeneration projects are now coming to fruition and we have provided input and worked closely with Otakaro, Christchurch City Council and Regenerate.

Air quality in Canterbury

We also manage air quality and made the Canterbury Air Regional Plan operative in October 2017. The welcome improvements we have seen in air quality have come from people changing to cleaner forms of heating and we will continue to support and encourage this through our subsidies for healthy homes.

Addressing climate change

Impacting everything we do are the effects of climate change which are already upon us. In May this year, we declared a climate emergency and were the first council in New Zealand to do so.

The declaration, which has been followed by several other councils, was to highlight both the urgent need to address climate change issues and the work already being done to help the region respond (as an organisation we sequester three times more carbon than we emit).

Big changes are coming, all of us are now being put under pressure to reduce our environmental footprint. While the focus has been on driving improvements in the farming sector over the past decade, it is now the turn of the whole of society to recognise that we must change too.

This includes urgently cleaning up urban rivers, moving away from the reliance on fossil fuel, thinking about what we eat, curbing plastic waste, as well as protecting our elite soils. We need to think globally and act locally.

As a community we are adaptive and collaborative – we have shown that hugely in Canterbury over the past decade – and by working together on solutions, some of which will be difficult, I am sure we will be able to ameliorate the pressing issues of climate change and sustainability confronting us.


GET YOUR RATES INVOICE BY EMAIL

Property owners in Christchurch and Banks Peninsula can now opt to receive their rates bill by email. From this month Christchurch City Council is offering people the choice of whether they want to receive their quarterly rates invoice and assessment notice by email or through the post. Signing up to get your rates bill by email is easy. All you need to do is fill in the online form at ccc.gov.t.nz/ratesinvoice. You will need your October rates invoice with you when you fill out the form as you will need your valuation number and unique document number to register for the service.

Once you have registered, you will receive your next rates invoice notice by email.

MARINE PILOT'S LIFE AT SEA

After 22 years of service, navigating over 5,000 vessels into Lyttelton Port, Marine Pilot and Governors Bay resident John Rendle has left his life at sea to enjoy a well-deserved retirement. John, known by most as JR, began working at the LPC in 1997 after a successful career at sea. John made a number of visits to Lyttelton during his worldwide voyages.

Before moving to New Zealand, John's parents worked as missionaries in Africa, which involved several voyages back and forth from Africa to the UK sparking his interest to work on the water. In 1966 at the age of 17, John headed out to sea as a cadet for Blue Star Line, working his way up to Chief Officer (First Mate) before returning to shore to teach navigation at Nelson Polytechnic for two years.

John then returned to the water, working for Pacifica's coastal shipping service for 15 years, 12 of which as a captain, before taking on a role as Marine Pilot at LPC. In his time working in Lyttelton, John has clocked a total of over 5,000 piloting, guiding a wide range of vessels safety into the Port.

John says he's thoroughly enjoyed his time working for LPC.

"It's a great bunch of people to work with – the people make the job."

A lot has changed about working as a Marine Pilot at LPC since 1997, particularly the increase of technology.

"There is an increasing emphasis on a regulatory approach and formal procedures for how a job is done along with the presence of web cameras, voice monitoring and AIS monitoring."

Navigation aids on vessels are also more prevalent and sophisticated, which adds a new dimension to the job, he says. There's also a general trending upwards in the size of ships being handled, he says, with container ships doubling in size over the last 10 years.



Different weather conditions encountered as a Marine Pilot can be interesting. Navigating rough weather can be challenging, but John says he has always enjoyed bringing vessels into Port.

LPC Marine Manager Andrew Van der Bent says John's contribution to LPC and the Marine Team has been significant.

"His positive attitude and great sense

of humour will be missed. Completing over 5,000 jobs for LPC highlights his incredible contribution to the Port."

John says he's looking forward to spending more time with his sweetheart Robyn, photography, music and listening to his vinyl records. He's also heading over to the UK for a holiday.

ASSOCIATE MINISTER SEEKS INPUT.

Associate Minister Poto Williams is inviting written comment on Christchurch City Council's request to have the on-site car parking requirements for new development's in Lyttelton's commercial zone removed from the Christchurch District Plan.

Ms Williams says the Christchurch District Plan requires developers to provide on-site parking in the Lyttelton commercial zone but does not take into account Lyttelton's unusual geography, and the size and shape of sites.

"Prospective developers in Lyttelton are generally unable to meet on-site parking requirements. The amendment being sought seeks to reflect the Lyttelton environment and provide greater clarity and certainty to redevelopment and regeneration of the town centre," Ms Williams says.

SUPER VETS

STORY CHATS DUNCAN

'Our records show your Tammy is 97 years old in June, Rachael, what's the problem?' Simon, the duty vet inquired. 'He's off his food and becoming lethargic again, like when he was 55, but you weren't here then, were you?'

'Er no, bit before my time. How many procedures has your dog had?'

'Now let me see, fourteen, no fifteen, I was forgetting his handsome new tail.'

Simon ran his hands down the dog's flanks, feeling.

'Umm, I don't feel anything wrong. You still keep Tammy on a strict vegetarian diet?

'Of course,' said Rachael, 'after the scare we had when his meat-eating master died. That shook us all up.'

'Well we best take him in for observation for a few days, alright?'

The Super Vet Clinic was in Corsair Bay, set among groomed gardens, overlooking the harbour. It was a large facility with extensive boarding kennels, three operating theatres and a heated, pets only, swimming pool. Plus, four short-stay luxury accommodation units to cater for overanxious owners, tastefully decorated with amazing animal prints by international photographers. Everything was top quality which was also reflected in the company's invoices.

facility's mission statement was above an impressive entrance way.

NEVER, EVER, BE PARTED FROM **PET**

almost continual pet life



by recycling body parts donated by other caring owners; who had experienced the dreadful agony of losing a close pet friend. Tammy was a typical recycled dog, whose life had been prolonged by spare parts.

Usually kept alive until their owners passed on, when they would be dis-assembled to add to the vast collection of replacement parts. Dog and cat legs, spare ears, tails and internal organs. All kept safely in frozen storage until needed for those highly expensive operations. Animals usually finished up a smorgasbord of inherited spare parts. But still loved to distraction.

Pet owners had yearned for extra years with their loves. Why should they have to face the extreme trauma of bereavement, when there was an alternative option. So, twenty years before, animal activists had founded the world's first Prolonged Life Clinic. Naturally, it was not without criticism, including UNICEF, who were unimpressed; suggesting the health and welfare of children came first. Nevertheless, the facility was oversubscribed from the beginning, and prospered.

Medical journals explored the reasons why the clinic had done so well, deciding it filled a void many felt was lacking in human society. People no longer cared about each other, many felt emotionally isolated. The world had degenerated into those few who possessed everything, those that aspired to join them, and the vast majority of ordinary people. So, desperate owners, in increasing numbers, turned their love and affection towards their pets, who could now out-live themselves.

Scandalous rumours about the clinic circulated from time to time. Cross-species experiments being a regular, unsubstantiated, claim. Dogs with cat fur and long-legged pooches, courtesy of Great Dane leg transplants, all strongly denied by the clinic. One much-publicised case concerned a goat loving American visitor, who supposedly had a goat's horn inserted into his forehead. Although an out-of-focus image circulated for some time, the man in question had disappeared back home to Idaho.

Over time, the majority of the public accepted the centre and its odd customers. Most taking the view that if pet owners chose to waste money, then that was their choice. Occasionally, the media exposed owners who had neglected children in favour of their pets, which usually involved the judicial system. However, one area of increasing concern was the inheritance issue. Pet owners having mortgaged their property to finance longer lives for their faithful pets, meant reduced inheritance's for their offspring.

Any article on the Prolonged Life Clinic must include a reference to, Monica, the cat lady. This affair almost closed the establishment for good, such was the outcry when news of her strange development became public knowledge. Monica Beal was a veterinary nurse, working alongside a senior consultant. Her admiration for the surgeon grew as she watched his operating skills. Monica became infatuated with her superior, and he with her.

Monica loved cats of all kinds and took to wearing, in secret and off duty, an exotic striped cat costume. In the privacy of her on-site quarters she would apply cat makeup to her face. Creating the most amazing cat features, complete with real cat whiskers. The costume had a long tail which she tried, unsuccessfully, to flick from side to side. Eventually, Monica decided she needed a real tail and cat claws - the whole caboodle. She made tearful overtures to the doctor who eventually gave her the operations she desired.

Once a video surfaced showing Monica, the cat lady, her lover was obliged to resign from the clinic, and together they fled to a more acceptable US; where they toured fun-fairs and large city malls, exhibiting the astonishing cat lady. Super Vets established new working guidelines to prevent any future human operations.
